CHANGE OF NAME OF OUE COMMERCIAL REAL ESTATE INVESTMENT TRUST AND THE MANAGER

OUE Commercial REIT Management Pte. Ltd., in its capacity as the manager of OUE Commercial Real Estate Investment Trust (the “**Trust**” and in its capacity as the manager of the Trust, the “**Manager**”), wishes to announce the following changes to the names and other particulars of the entities and securities referred to below.

1. Change of Name of the Trust

With the approval of DBS Trustee Limited, in its capacity as trustee of the Trust (the “**Trustee**”), the name of the Trust will be changed from “OUE Commercial Real Estate Investment Trust” to “OUE Real Estate Investment Trust” with effect from 29 January 2024. The Manager believes that the name change will better reflect the Trust’s diversified portfolio of commercial office, retail and hospitality assets.

In connection with the above, the trust deed dated 10 October 2013 constituting the Trust (as amended and restated) shall, pursuant to a supplemental deed to be entered into between the Trustee and the Manager, be amended to reflect the change of name of the Trust.

2. Change of Security and Counter Names of the Trust
